- Qualification in banking /Co-operative banking such as CAIIB/Diploma in Banking and Finance /Diploma in Co-operative Business Management or equivalent qualification ;or
- Chartered /Cost Accountant/MBA(Finance);or
- Post graduation in any discipline .

- 2.2 The person shall not be below the age of 35 years and above the age of 70 years at any time during his/her term in office. However, within the overall limit of 70 years, as part of their internal policy, individual bank's Boards are free to prescribe a lower retirement age.
- 2.3 The person shall have a combined experience of at least eight years at the middle/senior management level in the banking sector (including the experience gained in the concerned UCB) or non-banking finance companies engaged in lending (loan companies) and asset financing.
- 2.4 Knowledge of regional language may be considered as an advantage.
